January 10th, 2019 - You have five days to file your Unlawful Detainer Answer You count the first day as the day after you were served the complaint If the fifth day falls on a Court holiday or weekend you have until the following day to file example If you were served on Monday the 5th day is the next Monday because day 5 falls
